Timeline: 12/1/2024 - 12/1/2026

Budget: \$484,122.00

Okanogan Conservation District and its partners will create a county wide plan to address the threat of drought to our communities. The countywide plan will identify hardships associated with water supply and catalogue projects that will mitigate risks or improve resiliency.

Create a county wide plan that is a conglomeration of six smaller plans, each focusing on an area that can be geographically and demographically combined.



- Description of the entity(s) authorizing the LDPP. Includes an explanation as to why they are properly situated to accomplish the preparation of this LDPP for the project area.

Risk Assessment

Task Expected Outcome:

The assessments will describe the risks and vulnerabilities each area is facing regarding water security and categorize each risk or hardship by user group and level of impact as they relate to historical, current, and future projections of water supply and demand.

- Identify User Groups: Each Focus area and major users in those areas.
- Risks and Vulnerabilities of those groups
- Summarize available information on water supply factors in the planning area.
